1. Expenditure under S137 Local Government Act 1972 and S2 Local Government Act 2000

Section 137(1) of the 1972 Act permits the Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure. Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2021-22 was £8.41 per elector.

In 2021-22, the Council made payments totalling £415.00 under section 137. These payments are included within 'Other payments' in the Accounting Statement.

Auditor General's report and audit opinion

I certify that I have completed the audit of the Annual Return for the year ended 31 March 2022 of **Ysbyty Ystwyth Community Council**. My audit has been conducted on behalf of the Auditor General for Wales and in accordance with the requirements of the Public Audit (Wales) Act 2004 (the 2004 Act) and guidance issued by the Auditor General for Wales.

Requirement to give an audit opinion

I am required to come to an opinion as to whether or not any matters have come to my attention to give cause for concern that, in any material respect, the information reported in the Council's Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislative and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Disclaimer of audit opinion

Accounting Statement

I do not express an opinion on the Council's 2021-22 accounts.

Because of the significance of the matter described in the Basis for Disclaimer below, I have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion.

Annual Governance Statement

I do not express an opinion on the Council's 2021-22 Annual Governance Statement.

Because of the significance of the matter described in the Basis for Disclaimer below, I have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion.

Basis for Disclaimer

Each year the Council receives an audit notice that sets out the timetable for the audit and details of the information required to undertake the audit. Notwithstanding that:

- the Public Audit (Wales) Act 2004 requires the Council to make up its accounts to 31 March each year and to submit the accounts to the Auditor General, the

Council has disregarded the 2021-22 audit notice and did not submit the information required for the audit.

- On requesting a copy of the Council's cashbook, the Council stated it does not have a cashbook but maintains a spreadsheet of transactions. However, the Council failed to provide a copy of the spreadsheet.

I have therefore been unable to complete my audit of the 2021-22 accounts.

Significant governance deficiencies identified during the audit

I draw the reader's attention to the following deficiencies in the Council's governance arrangements identified at audit:

- Assertion 3: The Council does not publish on its website the information it is required to publish electronically by the Democracy and Boundary Commission Cymru etc. Act 2013 and the Local Government and Elections (Wales) Act 2021.

Other matters and recommendations

I draw the Council's attention to the following matters and recommendations which do not affect my audit opinion but should be addressed by the Council.

Recommendations

We recommend that the Council carefully examines the matters reported above and ensures that these are addressed before the audit of the 2024-25 accounts. Specifically, the Council must ensure that all relevant papers are provided for audit.

There are no further matters I wish to draw to the Council's attention.
