### Auditor General's report and audit opinion

I certify that I have completed the audit of the Annual Return for the year ended 31 March 2024 of **Ysbyty Ystwyth Community Council**. My audit has been conducted on \behalf of the Auditor General for Wales and in accordance with the requirements of the Public Audit (Wales) Act 2004 (the 2004 Act) and guidance issued by the Auditor General for Wales.

#### Audit opinion: Unqualified

On the basis of my audit, in my opinion no matters have come to my attention to give cause for concern that, in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislative and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

#### Other matters and recommendations

I draw the Council's attention to the following matters and recommendations which do not affect my audit opinion but should be addressed by the Council:

#### Incorrect income from taxation and total other payments figure

The Council has reported within line 2 a precept figure which excludes a deduction made by the Unitary Authority for costs to be paid to the authority. Therefore line 2 and line 6 are both understated, there is no effect on closing balances.

#### Chair signed the accounts before the internal auditor

The Chair signed the accounts before the internal auditor signed the accounts. We recommend that the Council ensure the Chair signs the accounts after the internal auditor has signed the accounts.

#### **Trust Funds**

Internal audit report states 'Yes' to question 11, whereas the Council have answered 'N/A' to question 9 on the Annual Governance Statement (these questions are in relation to trust funds). If the Council is acting as a sole trustee, they should answer 'Yes' or 'No' to question 9 on the Annual Governance Statement.
